Chairman's Report 2010/11

Following the Community Council elections in the Autumn of 2010 it was encouraging to have members of almost all the communities in the Kirriemuir Landward West area represented. The only exception is Westmuir and despite efforts by the previous Chairman to identify possible community councillors, no one has been forthcoming.

The introduction of the revised scheme for community councils has resulted in some changes to the workings of this council of which the most obvious is the introduction of an AGM.

One of the issues for the communities has been the perennial concern about road maintenance and two hard winters have done nothing to ease the problems. However thanks are due to many of the local farmers who turn out to clear the roads in the winter and without their efforts life would be significantly more difficult. The generally quick response of Angus Council to problems reported to the Accessline is also to be commended.

Planning matters and particularly those relating to renewable energy be it wind or water, have taken up the major part of several meetings and it is likely that in the current climate these matters will continue to be a central concern for members of the various communities in the Landward West area.

In conclusion I wish to thank the secretary and treasurer for their unstinting work behind the scenes, our three Angus Councillors who make the effort to attend our meetings and finally to all the community councillors for their attendance and work on behalf of their communities.
